



**NOTICE OF RACE**  
**Open Dutch & IILCA Euromasters Championship**

Organised by WSV Hoorn

Under the auspices of the Royal Netherlands Watersport Association (RNWA)

From 9<sup>th</sup> May to 12<sup>th</sup> May (inclusive) 2024.

location: Hoornse Hop – Hoorn

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

**1 RULES**

- 1.1 The event will be governed by the rules as defined in *The Racing Rules of Sailing (RRS)*. The Prescriptions of the RNWA can be found at <https://www.sailing.org/inside-world-sailing/rules-regulations/racing-rules-of-sailing/>
- 1.2 The 'Rules for (Open) Championships Sailing, Windsurfing and Kiteboarding' (available at reglement-voorkampioenschappen-20191101-v5-docx.pdf (watersportverbond.nl) will apply.
- 1.3 RRS 90.3(e) applies with a time limit of 48 hours. This changes RRS 90.3e. The sailing instructions may change other rules as well.
- 1.4 Sails shall have the full sail number AND NATIONAL LETTERS in accordance with the Class Rules and RRS. The national letters shall denote the National Authority of which the sailor is a member in accordance with RRS 75.2. This changes RRS Appendix G 1.1.
- 1.5 If there is a conflict between languages the text in the English language will take precedence.
- 1.6 Every person on board who has his domicile in the Netherlands shall have the appropriate license.
- 1.7 The GDPR declaration which can be found at [www.wsvhoorn.nl](http://www.wsvhoorn.nl)
- 1.8 RRS Appendix P applies.
- 1.9 RRS Appendix T, Arbitration, applies.
- 1.10 When rule 20.4(b) applies, a boat shall indicate her need for room to tack or her response by <communication>.

**3 COMMUNICATION**

- 3.1 Notices to competitors will be posted on the official notice board at the yacht club WSV Hoorn. And as a service to the sailors a copy will be placed at the whatsappgroup (which is not the official notice board). - 3.2 From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.



## 4 ELIGIBILITY AND ENTRY

- 4.1 The event is open to all boats of the Ilca class(es).
- 4.2 If you're not sure which Masters category you fall into, please refer to the table below. You shall reach the following ages during 2023 but should be 30 at the time of the first race of the event. :

30 to 44	ILCA 7 Apprentice Master (men only) ILCA 6 Apprentice Master (men and women)
45 to 54	ILCA 7 Master (men only) ILCA 6 Master (men and women)
55 to 64	ILCA 7 Grand Master (men only) ILCA 6 Grand Master (men and women)
65 and over	ILCA 6 Great Grand Master (men and women) ILCA 7 Great Grand Master (men only)
75 and over	ILCA 6 Legend (men and women)
30 and over	ILCA 4 (Women only)

- 4.4 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.5 Late entries will be accepted under the following conditions: Late entry fee: € 150,-

- 6.1 ILCA class rule 7 (a) is restricted as follows: "Only one person shall be on board whilst racing. The person shall be named on the entry form."

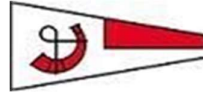
## 7 ADVERTISING

14.1 The intention is to appoint an international jury as provided in RRS 70.5

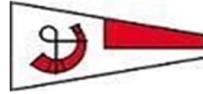
## 15 SCORING

15.1 Four races are required to be completed to constitute a series.

- 15.2
- (a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.
  - (b) When 5, 6, 7 or 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
  - (c) When 9 or 10 races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

15.3 RRS 90.3(e) applies with a time limit of 48 hours., only for the final results.

## 21 RISK STATEMENT

21.1 RRS3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, hypothermia or other causes.**

21.2 The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 22 INSURANCE

22.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of Euro 1.500.000 per event or the equivalent.

## 23 PRIZES

23.1 The RNWA supplies for the winning boat (ILCA 7 & 6 fleet) a blue pennant and a medal for the first three boats.

23.2 A Other prizes will be given as follows based on the number of entries per "Age group" registered on Sunday 7th April 2024:

Up to 5 competitors	1 prize
6 to 10 competitors	2 prizes
11+ competitors	3 prizes

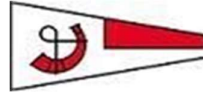
For Women will be 3 prizes

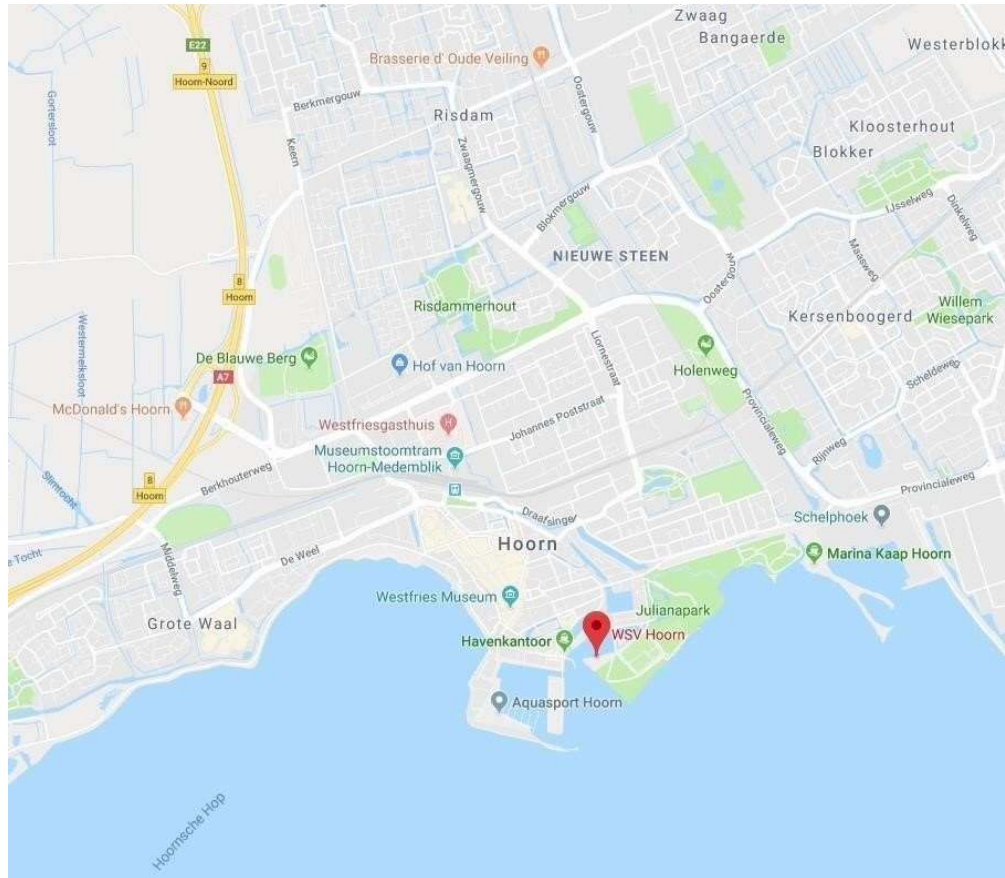
